## WIFI FAIR USAGE POLICY

### WiFi- Terms and Conditions

#### 1. Internet Services:

**1.1** The Academy of Gymnastics (“we” / “our” / “us”) provides you with access to the internet comprising of a wireless service in most areas of the club. By accessing the service by whatever medium you are agreeing to obey the terms and conditions listed below (the “Terms”). If you do not agree to the terms, please do not access the service.

#### 2. Fair Use:

**2.1** We would like to ensure that all our members have an enjoyable internet experience whilst on the club’s premises. We have, therefore, implemented a ‘fair use’ policy to ensure that we can continue to provide a fast and reliable service.

**2.2** We may monitor the performance of our network and the use of it by our members. If we notice that a member is using it more than what is expected from reasonable, normal use and where such excessive use is affecting other members or staff, particularly during busy times, we may restrict usage. If you do not use file sharing software or download large files from the internet then you should not be affected by our fair use policy. However, if it becomes clear that heavy downloading, peer-to-peer networking, or excessive streaming (i.e. more than simply streaming programme content from websites such as BBC iPlayer, 4 On Demand, or itv.com) is taking place then we may contact you to ask you to reduce your use to allow our other customers to share the system fairly. If you continue to do so, or if you persistently exceed normal use to the extent that it affects our network and other user’s enjoyment of the service, then we reserve the right to restrict or deny you access to the network.

#### 3. Our Obligations to You:

**3.1** We will use our reasonable endeavours to ensure that you are provided with free, uninterrupted service. We will not be liable however, for any reason if the service is not available at any time for any period, nor for any loss of data or damage to the equipment you suffer as a result of using our service. We may suspend access at any time and for any reason, including routine or emergency maintenance of the servers. For this reason, we strongly recommend that you regularly save any work you are doing whilst using the service.

**8.4** If any provision of this agreement is found to be unenforceable by a court of competent jurisdiction, the other provisions shall nevertheless remain in full force and effect.

**8.5** This agreement is governed by the laws of England and the parties hereto submit to the non-exclusive jurisdiction of the English courts.
